Project Location (include county): The Project is located on an unnamed tributary to Dry Creek at 4380 Highway 46 East in the City of Paso Robles, San Luis Obispo County, State of California; Township 26 South, Range 12 and 13 East, Section 24, United States Geological Survey (USGS) map Paso Robles and Estrella, MDB&M; 35.6546784,-120.629643; Assessor's Parcel Number 025-436-011.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement number 1600-2018-0261-R4, pursuant to section 1602 of the Fish and Game Code to the Project Applicant, Entrada de Paso Robles LLC.

The Project includes activities related to installation of four supports and rock slope protection associated with construction of a pedestrian bridge over the unnamed stream.

This is to advise that CDFW, acting as a Responsible Agency approved the above described project on 6/21/19 and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects CDFW considered in the mitigated negative declaration for this project pursuant to California Code of Regulations section 15096, subdivision (f).
2. Mitigation measures were made a condition of CDFW's approval of the project.
