Project Title: 01-0G330 Lake County Highway 20 Shoulder Project (Streambed Alteration Agreement Notification No. 1600-2020-0055-R2) Amendment #1

Project Location: The project is located at post miles 5.42, 5.52, 5.54, and 5.35 of State Route (SR) 20, with unnamed tributaries to Scott's Creek, in the County of Lake, State of California.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Amendment #1 to Streambed Alteration Agreement Notification Number 1600-2020-0055-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, California Department of Transportation.

Amendment #1 adds off-site restoration an alternative compensatory mitigation option in case on-site restoration and CDFW-approved bank credits are not feasible for the Permittee.

This is to advise that CDFW, acting as a Responsible Agency, executed the above-described Amendment #1 to the Streambed Alteration Agreement on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
