Project Description: The California Department of Toxic Substances Control (DTSC), pursuant to authority granted under California Code of Regulations, Title 22, Division 4.5, Chapter 20, Section 66270.40, is issuing a Post Closure Permit Renewal for Phillips 66 Company Wilmington (Phillips 66). DTSC shall extend the permitted post closure management period of the Phillips 66 Co Los Angeles Refinery - Wilmington Plant (Facility) for ten years through a permit renewal. The post closure permit is for the post closure care of a Stormwater Holding Basin No. 2 (SHB 2).

The Facility conducts groundwater monitoring, and groundwater and floating product extraction for the entire refinery pursuant to requirements of the Los Angeles Regional Water Quality Control Board (RWQCB) Cleanup and Abatement Order No. 94-139. Water Board has the oversight role for Corrective Action of the facility and DTSC has the oversight for Post Closure Permit and Post Closure Care of the Surface impoundment. The Facility does not conduct any manufacturing, hazardous waste generation or handling or participate in any other activities regulated by DTSC. The Facility has been under this RCRA Post-Closure status since 1999 and it has been managed and continues to be managed under an existing DTSC Post-Closure permit.

As Lead Agency under the California Environmental Quality Act (CEQA), DTSC approved the above-described project on September 30, 2021 and has made the following determinations:


1. The project will not have a significant effect on the environment.
