The Basin "CF" Groundwater Recharge Flood Control Project includes constructing a pump station at an existing District stormwater basin, Basin "CF", internal basin pipelines, a relief connection pipeline and intertie structure to the Fresno Irrigation District Washington Colony Canal. The project is the construction master planned facilities identified in the 2016 District Services Plan Update. The District has prepared an Initial Study for the project and has determined that the project would not result in any additional significant environmental effect not previously analyzed in the Subsequent EIR. No new additional mitigation measures or alternatives are required.


