**Project Title:** Rock Slough Fish Screen Routine Maintenance (Streambed Alteration Agreement No. EPIMS-CCA-15218-R3)

**Project Location:** The project is located on Rock Slough, a perennial tributary to Old River, in an unincorporated area in the County of Contra Costa, State of California; United States Geological Survey 7.5 Minute Quad Map Brentwood, Township 2N, Range 3E, Section 33; Latitude of 37.976173, Longitude: -121.641050; Assessor's Parcel Numbers: 020-140-049-6 and 020-140-051-2.

**Project Description:** The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement number EPIMS-CCA-15218-R3, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Contra Costa Water District, as represented by Christine Schneider.

Project activities under this Agreement are limited to routine maintenance activities such as aquatic weed contact herbicide application, hand and mechanical removal of aquatic weeds, pressure washing fish screens and bridges, etc.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on October 15, 2021, and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
