Project Title: Major Amendment to the Christie Road Mitigation Project (Lake or Streambed Alteration Agreement No. 1600-2017-0240-R3)

Project Location (Contra Costa County): The project is located on the south side of State Highway 4 just east of Christie Road, in the city of Hercules, County of Contra Costa, approximate GPS coordinates 37.99877, -122.19828.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed a major amendment to Streambed Alteration Agreement (1600-2017-0240-R3), pursuant to Fish and Game Code section 1602, issued to the permittee, the Richfield Real Estate Corporation, as represented by Dominic Leung.

The major amendment consists of the removal of a failed culvert underlying a ranch road, and the installation of a pre-cast concrete block ford in the same location as the failed culvert, in addition to the project activities covered under the original Lake or Streambed Alteration Agreement.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on March 11, 2024, and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the Environmental Impact Report prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were made a condition of CDFW's approval of the project.
4. A Mitigation Reporting or Monitoring Plan was adopted by CDFW for this project.
5. A Statement of Overriding Considerations was not adopted by CDFW for this project.
6. Findings were not made by CDFW pursuant to California Code of Regulations section 15091.
