Project Description: The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement number 1600-2013-0173-R4, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Pacific Gas and Electric Company.

Project Description: The Project includes activities related to the removal of woody vegetation within a 0.41-acre area on Morro Creek.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on 5/9/19 and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
