Coastal Development Permit, Site Development Permit, Planned Development Permit, and Tentative Map to subdivide one parcel to create eight new Lots, including five residential lots (Lots 1-5), each with new, 3-level, single dwelling units with a pool. Two of the lots will not be developed (Lots A and B), and one lot will serve as an access and utilities easement area (Lot C). Lot C will also serve as a private road with access and frontage to all five residential lots on portions of a 22.21-acre site. The project is located in the RS-1-4 Zone and Coastal Overlay (Non-Appealable) Zone within the La Jolla Community Plan area, Council District 1.
