**Project Title:** North Camino Ramon Specific Plan –Addendum & Development Applications (MJ 21-900-002, DP 21-300-002, AR 21-200-007, & IS 21-250-001)

**Project Location:** The City Village project area is located at 2400-2440 Camino Ramon on 31-acres of the approximately 295 acre North Camino Ramon Specific Plan Area.

**Project Description:** An Applicant-initiated Specific Plan Amendment to the North Camino Ramon Specific Plan and proposed vesting tentative map plans to subdivide an existing 31-acre subject property into 293 residential lots, a 2-acre private park (open to the public), and various common area parcels. The site plan includes 114 detached row homes, 154 detached courtyard homes, and 136 townhomes.

The project scope was previously analyzed by the North Camino Ramon Specific Plan Environmental Impact Report (EIR) (July 2012).

This is to advise that the City of San Ramon, as a Lead Agency has approved the above-described project on November 2, 2021 and has made the following determinations regarding the above described project:

1. The project will not have a significant effect on the environment and no new impacts were identified.
