NOTICE OF DETERMINATION – ATTACHMENT

On April 9, 2024, the Ventura County Board of Supervisors previously adopted Resolution 24-039 approving a substantive amendment to General Plan Policy COS-7.7 in a form that was later discovered to contain an administrative error regarding the amended language for this policy. The April 23, 2024, action that is subject of this Notice of Determination merely corrected the portion of that unintentionally misstated the language of amended Policy COS-7.7.

Because the April 23 action is solely an administrative revision and is not an action with the potential to directly or indirectly result in any physical change to the environment, it does not constitute a project that is subject to CEQA review. (CEQA Guidelines, §§ 15060(c), 15378(a).)
