Capitol Corridor Joint Powers Authority (CCJPA) is requesting a change to a published Notice of Preparation (NOP) previously submitted for the Sacramento to Roseville Third Main Track Project (SCH 2014072005). CCJPA is currently preparing a Supplemental EIR for the Sacramento to Roseville Third Main Track Project.
