**Project Title:** Notice of Determination for Golden Meadows Major Modification No. PLN21-0199 and Zoning Code Amendment No. PLN21-0201 – EIR Addendum “Nothing Further Required”

**Project Location (include county):** The project site is located north of Wickerd Road, south of Garbani Road, west of Sherman Road and east of Evans Road in the City of Menifee, County of Riverside, State of California (APNs 360-300-002, -003, -004, -005, -006, and -009 and 360-350-001).

**Project Description:** Major Modification No. PLN21-0199 proposes a Major Modification to Phase 4 of approved Tentative Tract Map No. 31194 to increase the number of residential lots from 161 to 240 within the previously approved project development area within Phase 4. The residential lots within Phase 4 will range in size from 4,000 square feet (6,000 square feet for all lots adjacent to Wickerd Road) to 12,420 square feet with an average lot size of 5,232 square feet. The project proposes eight (8) open space lots including a 3.23-acre public park and a 0.61-acre recreation/club house area.

Zoning Code Amendment (ZCA) No. PLN21-0201 proposes text revisions to Planned Development Districts - Section 9.155.030(E) (PD-5: Golden Meadows {TR 31194}) of the City of Menifee Municipal Code for purposes of establishing new minimum development standards to support the increase in residential density within Phase 4 of Tentative Tract Map No. 31194.

This is to advise that the City of Menifee, as the lead agency, has approved the above-referenced project on **December 6, 2023**, and has made the following determinations:

1. The project would not result in any new significant impacts and would not increase the severity of the previously identified significant impacts. Thus, the project does not constitute “substantial changes” that would require “major revisions” to the Golden Meadows Final Environmental Impact Report (FEIR) (State Clearinghouse [SCH] No. 2003061122) due to new or increased impacts (refer to Section 15162[a][1]). Additionally, the “circumstances under which the project” would be undertaken are not substantially different than described in the FEIR (refer to Section 15162[a][2]). Further, the project does not represent new information of substantial importance” that would result in new or greater impacts not discussed in the FEIR. For these reasons, a Subsequent EIR to address this new information is not required.
2. Because the proposed project does not meet the conditions described in Section 15162 of the CEQA Statute and Guidelines, the City determined that an addendum to the previously certified Golden Meadows FEIR is the appropriate documentation to address the proposed project. The environmental analysis presented in the Addendum to the FEIR demonstrates that the proposed project will not create new or greater significant environmental impacts than those identified in the previously certified FEIR.
3. An Addendum to the Golden Meadows FEIR was prepared for the project pursuant to the provisions of the CEQA.
4. Findings were made pursuant to the provisions of CEQA.
