Project Title: Permit No. 19735: American River Watershed Common Features Project / Natomas Post-Authorization Change Report / Natomas Levee Improvement Program / Landside Improvements Project Phase 4b: Utilities Near Bryte Bend Road and Orchard Lane

Project Location/City/County: located along the Garden Highway approximately 475 feet north-west from the intersection of Garden Highway and Bryte Bend Road to approximately 1440 ft west from the intersection of Garden Highway and Orchard Lane, in Sacramento County.

Project Description: Approval of Permit No. 19735, under California Code of Regulations, Title 23, Article 3, Section 6, for work within an adopted plan of flood control: To authorize installation of three (3) temporary wooden poles 3 to 8 feet from the edge of pavement along the waterside of the Garden Highway levee, and placement of ATT overhead communication lines along the waterside slope of the Garden Highway levee between Bryte Bend Road and Orchard Lane. The communication lines are to be attached to the SMUD poles, previously permitted under Board Permit 19637. The scope of work does not include any underground work. This utility relocation project (Project) is required for the Natomas Basin civil works project.

This is to advise that the Board, as the **Responsible Agency**, approved the above-described project on 7/10/23 and made the following determinations regarding the above-described project:

1. The project [will / will not] have a significant effect on the environment (This determination is limited to effects within the Board’s permitting jurisdiction as a responsible agency).
