

Chapter 34 Revised Draft EIR/Supplemental Draft EIS Document Distribution

The Authority and Reclamation are circulating this RDEIR/SDEIS for public and agency review and comment for a 60-day period following the Authority’s filing of the Notice of Completion with the Office of Planning and Research, State Clearinghouse and the U.S. Environmental Protection Agency’s publication of the Notice of Availability of Weekly Receipt of Environmental Impact Statement in the Federal Register.
