**Project Title:** Indian Creek Bridge Replacement (Lake or Streambed Alteration Agreement No. 1600-2020-0135-R2)

**Project Location (include county):** The project is located at Dogtown Road where it crosses over Indian Creek, in the County of Calaveras, State of California; Latitude 38.15, Longitude -120.5469 or Section 8, Township 03N, Range 13E, U.S. Geological Survey (USGS) map Calaveritas, MDM.

**Project Description:** The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement number 1600-2020-0135-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Joshua Pack of Calaveras County Department of Public Works.

The project includes the replacement of the existing Dogtown Road Bridge (Bridge No. 30C0050) over Indian Creek located in the central portion of Calaveras County and within a rural area of the Sierra Nevada foothills.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project, on the date signed below, and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
