Project Title: Vallejo Storm Drain Replacement Work (Lake or Streambed Alteration Agreement No. EPIMS- SOL-27820-R3)

Project Location (Solano County): The Project is located on the shoreline of the Mare Island Strait in the City of Vallejo, County of Solano, State of California. The Project is located on Assessor's Parcel Number 0058-090-230 and centered at approximate Latitude 38.09371°N, Longitude 122.2555°W.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement (EPIMS- SOL-27820-R3), pursuant to Fish and Game Code section 1602, to the project Applicant, Pacific Gas and Electric Company.

The Project is limited to installation of a new stormwater drain outfall to Mare Island Strait, as part of a larger upland soil remediation project. The Project will install a 60-inch diameter storm drain outfall, and associated headwall and riprap. The Project will result in 0.07 acres in temporary impacts from the installation of an approximately 3,000 square foot temporary cofferdam to isolate the work area from the straight and temporary dewatering pumps. The new outfall will require excavation of approximately 400 cubic yards of shoreline. No loss of channel or shallow water habitat will occur as excavation and placed riprap will occur within a currently riprapped location. No vegetation or trees will be impacted by the project.


This is to advise that CDFW, acting as a Responsible Agency, approved the project described above on October 3, 2022, and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the **Negative Declaration and Addendum** prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures **were** made a condition of CDFW's approval of the project.
4. A Mitigation Reporting or Monitoring Plan **was** adopted by CDFW for this project.
5. A Statement of Overriding Considerations **was not** adopted by CDFW for this project.
6. Findings were not made by CDFW pursuant to California Code of Regulations section 15091.
