The California Department of Transportation (Caltrans) has completed the Draft Environmental Impact Report/Environmental Assessment (EIR/EA) for the State Route 1 (SR-1/Lincoln Boulevard) Multimodal Improvements Project (project). The proposed project would improve circulation and safety along Lincoln Boulevard by constructing an additional southbound lane, installing sidewalks and protected bicycle lanes, and implementing complete streets and other related improvements along a segment of Lincoln Boulevard between Jefferson Boulevard and just south of Fiji Way.
