Project Location (include county): The project site is in unincorporated Fresno County, approximately 3.5 miles southwest of the community of Tranquility, 6.5 miles east of Interstate 5 (I-5), south of W. South Avenue, north of W. Dinuba Avenue, east of State Route 33 (S. Derrick Ave.) and west of S. San Mateo Avenue.

Project Description: Unclassified Conditional Use Permit No. 3555 and associated EIR No. 7230 to construct, operate, maintain, and decommission a 400-megawatt (MW) solar photovoltaic (PV) electricity generating facility and 400 MW energy storage system and associated infrastructure. It would provide solar power to utility customers by interconnecting to the regional electricity grid at Pacific Gas and Electric Company's (PG&E) Tranquillity Switching Station.
