The proposed project consists of an amendment to the existing Mining and Reclamation Plan and associated Conditional Use Permit with modifications of the proposed mining area, practices, and mining methodology initially analyzed in the 2004 Hogsback Quarry Mining and Reclamation Final Environmental Impact Report (EIR) and Conditional Use Permit (UP 2001-01) issued by the Modoc County Planning Department.
