Project Title: French Camp Slough Storm Drain Outfall (Lake and Streambed Alteration Agreement EPIMS Notification No. SJN-34173-R2)

Project Location (include county): The project is located at French Slough, a tributary to the San Joaquin River, in the County of San Joaquin, State of California; Latitude 37.886878, Longitude -121.255386 (WGS 84 datum, decimal degrees); Assessor's Parcel Number 177-050-310.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement EPIMS Notification Number SJN-34173-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Armoto Partners, LLC, as represented by Matt Arnaiz.

The project includes the installation of a concrete outfall structure, associated wingwall and armoring, and a pump station on French Camp Slough.

This is to advise that CDFW, acting as a Responsible Agency, executed the above Lake and Streambed Alteration Agreement on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will / will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
