Project Description	This project is for the conveyance of up to 35,000 acre-feet of the San Joaquin River Exchange Contractors Water Authority's 2024 Central Valley Project (CVP) water (Non-Project Water) to KCWA under Article 55 of KCWA's Water Supply Contract with DWR. This Non-Project Water will be delivered to Rosedale-Rio Bravo Water Storage District, a member unit of KCWA, which lies within both the State Water Project (SWP) and CVP places of use. This Non-Project Water will be made available by the United States Bureau of Reclamation to DWR at O'Neill Forebay for subsequent delivery by DWR to KCWA's service area through February 28, 2025.
Determination	<p>This is to advise that DWR, acting as a Responsible Agency, approved the project described above on November 4, 2024 and has made the following determinations:</p> <ol style="list-style-type: none"> 1. The project will not have a significant effect on the environment. 2. Pursuant to CEQA, San Joaquin River Exchange Contractors Water Authority, as the lead public agency, prepared an Environmental Impact Report/Environmental Impact Statement jointly with the United States Bureau of Reclamation for this project. DWR independently reviewed and considered this environmental documentation prior to approving the project. The project is within the scope of the Final EIR/EIS and no additional environmental review is required pursuant to CEQA Guidelines 15162. 3. Mitigation measures, as described in Chapter 14 of the Final EIR/EIS (SCH 2011061057), were made a condition of the approval of the project. San Joaquin River Exchange Contractors Water
