**Project Title:** Smith Stream Crossings Project (Lake or Streambed Alteration Agreement No. 1600-2020-0173-R1)

**Project Location:** The project is located within the Eel River watershed, approximately 1 mile Southwest of the town of Garberville, County of Humboldt, State of California; Section 26, T4S, R3E, Humboldt Base and Meridian, in the Garberville U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 222-231-012; latitude 40.0913 N and longitude -123.8154 W at the point of the first stream crossing (RP111).

**Project Description:** The project is limited to 1 encroachment. The one encroachment is to upgrade a failing and undersized stream crossing. Work for this encroachment will include excavation, removal of the failing crossings, replacement with new properly sized crossings, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as  the Lead Agency /  a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
