Project Title: Radomski Diversion and Streambank Remediation Project (Lake or Streambed Alteration Agreement No. EPIMS-HUM-19637-R1C)

Project Location: The project is located within the Minor Creek watershed, approximately 10 miles east of the town of Blue Lake, County of Humboldt, State of California; Section 11, T06N, R03E, Humboldt Base and Meridian, in the Lord Ellis Summit U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 316-292-021-000; latitude 40.9199 N and longitude 123.7983 W at the point of diversion (POD).

Project Description: The project is limited to two (2) encroachments. The first encroachment is for water diversion from an unnamed tributary to Captain Creek. Water is diverted for domestic use only. Work for the water diversion will include installation of an appropriate collection vessel (e.g., spring box that meets the requirements in this Agreement), use, and maintenance of the water diversion infrastructure. The second encroachment is for the (partial) remediation and armoring of the bank of Captain Creek due to unpermitted cut-bank steps being previously installed.

This is to advise that the California Department of Fish and Wildlife (CDFW), acting as the lead agency / a responsible agency approved the above-described project and has made the following determinations:
