Project Title: Marinov Stream Crossings and Restoration Project (Lake or Streambed Alteration Agreement No. EPIMS-HUM-14721-R1)

Project Location: The project is located within the Coleman Creek watershed, approximately 9 3/4 miles east of the town of Myers Flat, County of Humboldt, State of California; Assessor's Parcel Numbers 217-401-021 and 217-401-022; latitude 40.2936 N and longitude 123.6935 W.

Project Description: The project includes two proposed encroachments. The first encroachment will upgrade a stream crossing. The second encroachment will upgrade a stream crossing and restore a stream impacted by the unauthorized grading of a flat and road. Work for these encroachments includes excavation, removal of the existing culverts and water lines, replacement with new culverts, backfilling and compaction of fill, recontouring and revegetating impacted areas, and rock armoring as necessary to minimize erosion

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
