Project Title: Mills Stream Remediation and Revegetation Project (Lake or Streambed Alteration Agreement No. EPIMS-HUM-14637-R1)


Project Location: The project is located within the Powers Creek watershed, approximately 3 miles southwest of the town of Alderpoint, County of Humboldt, State of California; Assessor's Parcel Number 216-382-021; 40.1466 N, 123.6548 W at the site of the remediation.

Project Description: The project consists of one encroachment for the of 100-foot long stream segment impacted by unauthorized grading and tree removal in the Streamside Management Area (SMA). Work for this encroachment will include excavation and recontouring of the banks and stream channel; removal and/or disposal of cultivation infrastructure (i.e. water bladder, irrigation line, etc.); and replanting trees, shrubs and other native vegetation at a 3:1 ratio to mitigate for those recently removed from the SMA.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. An Environmental Impact Report was prepared for this project pursuant to the provisions of CEQA. CDFW considered the Environmental Impact Report prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were / were not made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was / was not adopted by CDFW for this project.
5. A Statement of Overriding Considerations was not adopted by CDFW for this project.
6. Findings were not made by CDFW pursuant to Public Resources Code section 21081, subdivision (a).
