Project Title: Anguelova Water Diversion and Remediation Project (Lake or Streambed Alteration Agreement No. EPIMS-HUM-25839-R1)

Project Location: The project is located within the Mattole River watershed, approximately 3.3 miles southeast of the town of Honeydew, County of Humboldt, State of California. The project is located in Section 20, T3S, R1E, Humboldt Base and Meridian; in the Honeydew U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 107-261-004; latitude 40.1986 N and longitude 124.1010 W at the point of diversion (POD).

Project Description: The project is limited to four encroachments. One encroachment is for water diversion from an unnamed tributary to Fourmile Creek. Water is diverted for domestic use. Work for the water diversion will include use and maintenance of the water diversion infrastructure. One encroachment shall upgrade the overflow structure of an existing onstream stock-pond. One encroachment shall remove a septic tank, staircase, and constructed drainage ditch to prevent future stream diversion and return streamflow to its original channel. One encroachment shall remove a septic tank from the head of a stream. Work for these encroachments will include excavation, removal of the existing infrastructure and debris, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. An Environmental Impact Report was prepared for this project pursuant to the provisions of CEQA. CDFW considered the Environmental Impact Report prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were / were not made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was / was not adopted by CDFW for this project.
5. A Statement of Overriding Considerations was not adopted by CDFW for this project.
6. Findings were not made by CDFW pursuant to Public Resources Code section 21081, subdivision (a).
