Project Location: The project to be completed is located within the Mad River watershed, approximately one mile northeast of the town of Blue Lake, County of Humboldt, State of California. The project is located in Section 20, T06N, R02E, Humboldt Base and Meridian; in the Blue Lake U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 312-190-006-000; latitude 40.8898 N and longitude 123.9767 W at the point of diversion (POD).

Project Description: The project to be completed is located within the Mad River watershed, approximately one mile northeast of the town of Blue Lake, County of Humboldt, State of California. The project is located in Section 20, T06N, R02E, Humboldt Base and Meridian; in the Blue Lake U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number (APN) 312-190-006-000; latitude 40.8898 N and longitude 123.9767 W at the point of diversion (POD).

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above-described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):
