**Project Title:** Mattson Hydrologically Connected Well Project (Lake or Streambed Alteration Agreement No. EPIMS-47416-R1C)

**Project Location:** The Project to be completed is located within the Van Duzen River watershed, approximately 2.8 miles southeast of the town of Carlotta, County of Humboldt, State of California. The Project is located in Section 36, T02N, R01E, Humboldt Base and Meridian; in the Hydesville U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 206-191-019-000; latitude 40.5097 N and longitude 124.0171 W at the hydrologically connected well (located on APN 206-451-005-000).

**Project Description:** The Project is limited to one encroachment. The single encroachment is for water diversion from a well hydrologically connected to the Van Duzen River. Water is diverted for domestic use and irrigation. Work for the water diversion will include use and maintenance of the water diversion infrastructure.

This is to advise that CDFW, acting as  the Lead Agency /  a Responsible Agency approved the above-described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
