Project Title: Vasilyev Stream Crossings Project (Lake or Streambed Alteration Agreement No. EPIMS-HUM-49071-R1C)

Project Location: The project is located approximately 6.6 miles southwest of the Town of Dinsmore; affecting one unnamed tributary to Van Duzen River in the County of Humboldt, State of California; Section 35, Township 1N, Range 4E; Humboldt Base and Meridian, in the Larabee Valley, Calif. 7.5-minute quadrangle, U.S. Geological Survey (USGS) map; Assessor's Parcel Number 210-074-001.

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number EPIMS-HUM-49071-R1C, pursuant to Section 1602 of the Fish and Game Code to Alex Vasilyev. The project consists of 6 encroachment(s): The six encroachments are to upgrade or decommission six stream crossings. Work for these encroachments will include excavation, installation of new culverts, placement of rock armoring, and implementation of erosion control as necessary to minimize erosion.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
