Project Title: Lindsey Water Diversion Crossings Project (Lake or Streambed Alteration Agreement No. EPIMS-05648-HUM-R1)

Project Location: The project is located within the Lower Eel River watershed, approximately 14 miles Northeast of the town of Garberville, County of Humboldt, State of California; Section 03, T05, R12, Humboldt Base and Meridian, in the Alderpoint U.S. Geological Survey 7.5-minute quadrangle; Assessor’s Parcel Number 216-205-005 ; latitude 40.2105 N and longitude -123.5712 W at the point of diversion (POD).

Project Description: The project is limited to 1 encroachments. 1 encroachment is for water diversion from an unnamed spring. Water is diverted for domestic use only. Work for the water diversion will include use and maintenance of the water diversion infrastructure.

This is to advise that the California Department of Fish and Wildlife (CDFW), acting as **the lead agency** / **a responsible agency** approved the above-described project and has made the following determinations:
