Project Location (include county): The project is located on SR-74 from 0.8 mile west of the San Juan Hot Springs Canyon (Post Mile [PM] 11.50) to the Orange/Riverside County line (PM 16.60) in the County of Orange.

Project Description: This proposed project involves invert paving existing pipes, placing rip rap, installing drainage inlets, grading, and installing new reinforced concrete pipes to divert sheet flow across the roadway.
