Project Title: Monterey Bay Education, Science and Technology Center (California Endangered Species Act Incidental Take Permit No. 2081-2000-052-03 (ITP) Minor Amendment No. 1)

Project Location: The Project is located off Reservation Road near Imjin Road, in Monterey County, adjacent to the City of Marina, on lands owned and managed by each Permittee as follows:

University of California, Santa Cruz: Accessor's Parcel Numbers 031-111-039, 031-111-040, 031-101-018, 031-121-002, 031-121-007, 031-121-008, and 031-111-027

Rutherford Investments Company, LLC: Accessor's Parcel Numbers 031-111-041, 031-111-042, 031-111-043

Project Description: This project includes development of 484-acres as a mixed-use project including up to 5 million square feet of developed space, and management of the mitigation activities required in the "Sand Gilia & Seaside Bird's-Beak Mitigation Plan." Project activities include grading; cut and fill (leveling); installation of fencing, utilities, and wastewater and stormwater collection infrastructure; concrete paving; landscaping; construction of driveways and buildings; operation of heavy equipment; ground compaction; stockpiling and deposit of soils; material and equipment transport and laydown; and trenching and backfilling (collectively referred to as Covered Activities).

Work on the Project under the ITP has begun and Minor Amendment No. 1 (Amendment) includes several changes to the ITP as originally issued. These changes include, but are not limited to, the addition of an additional Permittee, modification of both the Project Location and Project Description, and inclusion of requirements to formally identify Designated Representatives and Designated Biologists and add notification requirements to ensure compliance with the ITP.

The Project will result in impacts to 7.9 acres of occupied Sand gilia (*Gilia tenuiflora ssp. arenaria*) habitat and 0.03 acres of occupied Seaside bird's-beak (*Corydylanthus rigidus ssp. litteralis*) habitat. The project is expected to result in incidental take of Sand gilia and Seaside bird's-beak, which are designated as threatened and endangered species, respectively, under the California Endangered Species Act. The ITP referenced above as issued by CDFW authorizes incidental take of species listed under CESA that may occur as a result of Project implementation.
