Title: The Low-Energy Offshore Geophysical Permit Program (OGPP) Update

Applicant: The Regents of the University of California, San Diego / Scripps Institution of Oceanography

Location: Offshore, in State Marine Waters (as defined in title 2, Cal. Code of Regs., sec. 2100.03(h)), from the mean high tide line to 3 miles offshore including granted or ungranted tidelands and submerged lands

Description: The California State Lands Commission has statutory authority, pursuant to Public Resources Code section 6826, to issue geophysical permits in State waters to qualified permittees for the use of low energy geophysical equipment to perform geophysical surveys of the ocean bottom, subject to specified terms and conditions. The State Lands Commission action is issuing a 3-year non-exclusive geophysical survey permit through December 16, 2027.

This is to advise that the California State Lands Commission, as  Lead Agency  Responsible Agency, approved the above-described project on December 17, 2024, and made the following determinations regarding the project.

- 1) The project  will  will not have a significant effect on the environment.
- 2) A  Mitigated Negative Declaration (MND) was prepared for this project pursuant to the provisions of CEQA.
- 3) Mitigation measures  were  were not made a condition of the approval of the project.
- 4) A mitigation reporting or monitoring plan  was or  was not adopted for this project.
- 5) A Statement of Overriding Considerations  was  was not adopted for the project.
- 6) Findings  were  were not made pursuant to the provisions of CEQA.

The Mitigated Negative Declaration (MND) and Mitigation Monitoring Program (MMP) were prepared for this project by the California State Lands Commission and adopted on September 20, 2013, as modified by the addendum to the MND and revised General Permit and MMP, adopted on April 23, 2014.
