**Project Title:** Butte City Bridge Replacement (Streambed Alteration Agreement No. 1600-2020-0209-R2)

**Project Location (include county):** The Project is located on State Route 162 at post miles GLE-162 76.7 - 77.6, at the Sacramento River and Razor Slough in the County of Glenn, California.

**Project Description:** The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement number 1600-2020-0209-R2, pursuant to section 1602 of the Fish and Game Code to the Project Applicant, California Department of Transportation. The Project is limited to the replacement of the existing bridge across the Sacramento River (PM 77.3 to 77.6) and the replacement of the existing viaduct across the Sacramento River floodplain (PM 76.7 to 77.45). Excavation, backfill, grading, vegetation removal, concrete work, dewatering, and in-water pile driving will be completed. This is to advise that CDFW, acting as a Responsible Agency, approved the above described Project on the date signed below and has made the following determinations regarding the Project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The Project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the  mitigated negative declaration /  negative declaration prepared by the Lead Agency for this Project pursuant to California Code of Regulations section 15096, subdivision (f).
