Project Title: Streambed Alteration Agreement No. 1600-2019-0032-R2 "Mulligan" THP

Project Location: The projects are located in portions of Sections 24, 25, 26, 27, 35, and 36 of Township 6N, Range 15E; and Sections 20, 29, 30, and 31 of Township 6N, Range 16E; U.S. Geological Survey (USGS) Quad maps Dorrington and Boards Crossing, Mt. Diablo Base and Meridian. More information (including maps) can be found in the Timber Harvest Plan (THP) 4-18-016-CAL.

Project Description: The projects are limited to the 26 projects identified in the Notification: The use and maintenance of eight existing water drafting sites, the creation and use of four water drafting sites (three in-channel and one off-channel), the installation of three new permanent culvert road crossings, the maintenance and/or replacement of nine existing culvert road crossings, the maintenance of one rocked ford, and the creation of one temporary skid crossing.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the mitigated negative declaration / negative declaration / timber harvesting plan prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were / were not made a condition of CDFW's approval of the project.
