PROJECT DESCRIPTION: This is a General Plan/ Local Coastal Program (LCP) Amendment of the Mobility Element that proposes more sustainable modes of transportation and approval of the Climate Action Plan (CAP) that provides for the reduction of greenhouse gases (GHG). MF 1234

This is to advise that the City of Imperial Beach as Lead Agency has approved the above described project on July 17, 2019 and has made the following determinations regarding the above described project:
