**NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

Notice is hereby given that the public agency named below has completed an Initial Study of the following described project at the following location: , Colton CA

Project Location – Ashley Way Colton, CA 92343  APNs: 027-614-449, 027-614-448, 027-614-453, 027-614-452	<b>DAP-001-536</b> – The applicant proposes to develop a 220,185 square foot logistical center on a 11.19-acre site consisting of a 10,000 square foot office, two warehouse structures, 156 parking stalls (including an employee lot with 6 ADA-accessible spaces and a truck yard lot), and associated landscaping totaling 93,585 square feet. The logistical center/warehouse distribution facility includes features to accommodate 28 semi-trucks to dock at high door positions. The main front entrance faces north toward Ashley Way and all truck docking activity would occur on the south side of the building. The project also includes a General Plan Amendment from Commercial to Light Industrial, a Zone Change from C-2 (General Commercial) to M-1 (Light Industrial), and a Parcel Map (PM-20080) to consolidate four parcels into one.	
This Initial Study was completed in accordance with the Lead Agency’s Guidelines for Implementing the California Environmental Quality Act. This Initial Study was undertaken for the purpose of deciding whether the project may have a significant effect on the environment. On the basis of such Initial Study, the Lead Agency’s Staff has concluded that the project will not have a significant effect on the environment, and has therefore prepared a Draft Mitigated Negative Declaration. The Initial Study reflects the independent judgment of the Lead Agency.
