Project Description: The California Department of Fish and Wildlife (CDFW) has executed the Lake and Streambed Alteration Agreement (EPIMS- SOL-26955-R3), pursuant to Fish and Game Code section 1602, to the project Applicant, California Department of Water Resources.

The project is limited to the repair of levees at seven (7) locations at Cache and Lindsay Sloughs in Solano County. The construction of each site is organized into the following stages: 1) mobilization (creating site access and staging areas), 2) site preparation (vegetation clearing and grubbing), 3) levee repair, 4) demobilization, restoration, and clean up.

This is to advise that CDFW, acting as a Responsible Agency, approved the project described above on May 30, 2023 and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

- 1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
- 2. CDFW considered the **Mitigated Negative Declaration** prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
- 3. Mitigation measures were made a condition of CDFW's approval of the project.
