Project Title: Iowa City Road Over Jack Slough Bridge (Bridge No. 16C0077) Replacement Project (Streambed Alteration Agreement No. YUB-14840-R2)

Project Location (include county): The project is located at Jack Slough tributary to the Feather, in the County of Yuba, State of California; Latitude 39.294123, Longitude -121.489755, Township 17N, Range 4E, Section 35 of Loma Rica 7.5 minute U.S. Geological Survey (USGS) map, Mount Diablo Base and; Assessor's Parcel Number 003-110-045.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement number YUB-14840-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Yuba County Public Works Department.

The project is limited to the replacement of the existing Iowa City Road Bridge, re-aligning the road approaches, and removal of the old bridge.

This is to advise that CDFW, acting as a Responsible Agency, executed the above described Streambed Alteration Agreement on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were / were not made a condition of CDFW's approval of the project.
