The modified project would create a publicly accessible scenic overlook and trail to the Montara Mountain North Peak instead of installing new radar and radio facilities at the site. Should the need arise, however, the possibility remains for the radar and radio facilities to be installed at the site in the future. The SFPUC is installing a radar system at a lower elevation within the watershed at Sawyer Ridge (San Francisco Planning Department Categorical Exemption, SFPUC Water Radio Replacement West Bay Region Network, Planning Department Case No. 2022-010348ENV, February 16, 2023). The SFPUC will evaluate the performance of this radar system and, if it does not function adequately and another suitable location cannot be found, the radar facility as approved in the original project may be constructed at some future time on the Montara Mountain project site.
