Notice of Intent to Adopt a Mitigated Negative Declaration (Study Results Available) and Opportunity for a Public Hearing

**Do you want a public hearing on changes proposed on State Route 1
in Santa Cruz County for the Davenport Culverts Replacement Project ?**

PUBLIC COMMENT PERIOD

Comments will be accepted from
June 27, 2019 to July 29, 2019

If there are no major comments, Caltrans will proceed with the project's design.

WHAT IS BEING PLANNED?

The California Department of Transportation (Caltrans) is proposing to replace four existing corrugated metal pipe (CMP) culverts on State Route 1 (SR-1) at post miles (PM), 32.12, 33.90, 34.15 and 35.49 in Santa Cruz County. The culverts are located along the California coast and crosses under SR-1. Due to the age and deteriorating conditions of the existing culverts, replacements of these culverts are being proposed.

WHY THIS PUBLIC NOTICE?

Caltrans has studied the effects this project may have on the environment. Our studies show it will not significantly affect the quality of the environment. The report that explains why is called an Initial Study with Proposed Mitigated Negative Declaration. This public notice is to inform you of the preparation of the Initial Study with Proposed Mitigated Negative Declaration and of its availability for public review and comment. This notice also offers you an opportunity to request a public hearing.

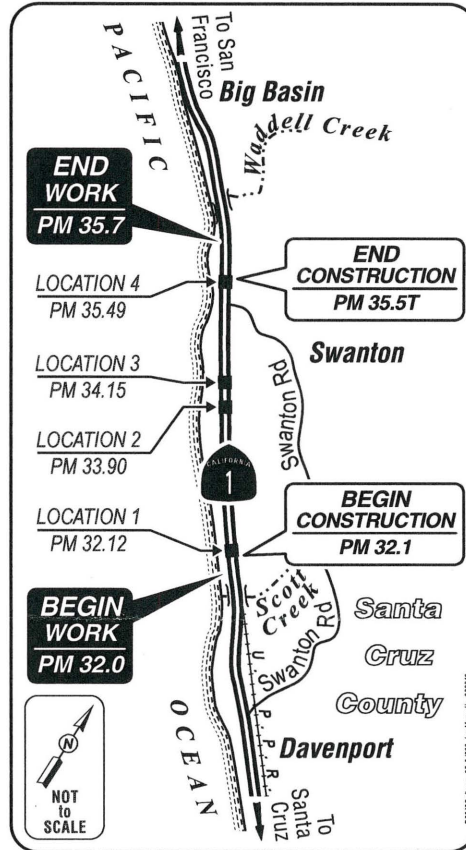
