Reasons why project is exempt:

This project will involve the installation of a solar energy system on one carport at a parking lot that has existed for over two years and pursuant to Pub. Res. Code § 21080.35 is exempt from CEQA. The materials will enable the generation and use of solar PV. The system will be installed at a vegetable farm in Monterey County. Associated equipment will not occupy more than 500 square feet of ground surface.

The project does not involve a federal Clean Water Act permit; waste discharge requirements under Porter-Cologne Water Quality Control Act; individual take permit; streambed alteration permit; or removal of specific required or native trees. For these reasons, this project is statutorily exempt from CEQA under Pub. Res. Code § 21080.35.

This project will involve the installation of an electric vehicle charger under carport at a vegetable farm in Monterey County. The charger will serve electric vehicles. This project involves installation of a carport of small new equipment in a small structure. The project falls under categorical exemption listed in 14 CCR section 15303.

This project will involve replacement of a diesel-powered water pump with an electric-powered pump at a vegetable farm in Monterey County. The pump is for irrigation purposes. The new pump is on the same site as the original pump and has substantially the same purpose and capacity as the original pump. The project falls under categorical exemption listed in 14 CCR section 15302.

Each exemption is an independent basis for finding the project exempt.
