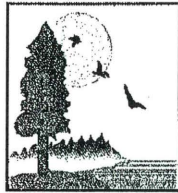


Categorical Exemption:
