## Notice of Preparation and Notice of Public Scoping Meeting

**Date:** July 25, 2019

**To:** Responsible and Trustee Agencies and Interested Parties

**Lead Agency:** Orange County Sanitation District

**Subject:** Notice of Preparation of a Programmatic Environmental Impact Report and Notice of Public Scoping Meeting for the Orange County Sanitation District Facilities Master Plan, Project No. PS17-08

The Orange County Sanitation District (Sanitation District) is commencing preparation of a Program Environmental Impact Report (EIR) to evaluate the potential environmental impacts associated with implementation of its 2017 Wastewater Collection and Treatment Facilities Master Plan (FMP), which was updated in 2019 with additional projects. The purpose of this letter is (1) to serve as a Notice of Preparation (NOP) of an EIR pursuant to the California Environmental Quality Act (CEQA), (2) to solicit comments and suggestions regarding the scope and content of the EIR to be prepared, and (3) to provide notice of a public scoping meeting.

The Sanitation District is proposing to implement its updated FMP, which will allow the Sanitation District to upgrade, replace, rehabilitate, and maintain existing facilities within the Sanitation District's wastewater collection and treatment system. The FMP identifies individual projects located throughout the Sanitation District's service area that would occur over the course of a 20-year planning period. Projects can be generally categorized into three categories: (1) projects occurring at Reclamation Plant No. 1 in Fountain Valley; (2) projects occurring at Treatment Plant No. 2 in Huntington Beach; and (3) projects involving pipelines and pump stations occurring throughout the Sanitation District's service area.

## Notice of Preparation of a Program EIR and Solicitation of Comments

In accordance with CEQA, the Sanitation District is circulating this NOP to notify interested parties that the Sanitation District has prepared an Initial Study and has independently determined that there are potentially significant impacts associated with its implementation, and that an EIR is required.

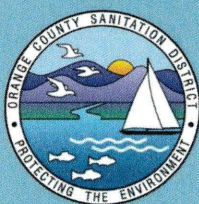
