Project Description (Proposed actions, location, and/or consequences).

The Hacienda La Puente Unified School District (District) is proposing to redevelop a 20-acre project site consisting of the existing Wedgeworth Elementary School, four baseball fields, and vacant area, to provide a new K-8 school on 10 acres and sell the remaining 10 acres to residential developers to construct up to 160 residential units. The existing school has capacity for 600 K-5 students, and the new school would have capacity for 1,200 K-8 students, an increase enrollment capacity for 600 students. This initial study evaluates the potential environmental consequences and impacts of this proposed project.
