Minor Master Plan Revision
San Francisco State University

As provided by Executive Order No. 630, I hereby approve the requested June 2019 minor master plan revision for the following action:

1. Switch the location of the proposed Science Replacement Building (#53), currently sited near the existing Gymnasium (#5) with the location of the future Academic Building (#14), currently sited near the existing Science building (#4). This change will allow for the proposed Science Replacement Building to be located near the existing science instructional and research facilities on the northeast corner of campus. The 1960's era portion of the existing Science Building will be demolished, and the new facility will be constructed in its place. There is no plan to relocate the existing Gymnasium at this time, so the use of that site is not a feasible option for the Science Replacement Building.

Approval of this revision is consistent with Criteria #3 of Executive Order No. 630, which allows for a relocation of a maximum of three approved but yet to be constructed facilities to a more advantageous site, provided the overall utilization of the campus land area is not increased or the amount of open space decreased. The planned facilities are consistent with the campus architectural vocabulary, and the campus master plan architect supports the proposed changes. A Notice of Exemption will be filed with the State Clearinghouse by the campus.

The minor master plan revision should be incorporated into the campus master plan graphic for inclusion in the 2020-2021 Capital Outlay Program and Five-Year Capital Improvement Plan.
