


The project proposes to replace AC surfacing at the Maxwell Safety Roadside Rest Area (SRRA) on Interstate 5 (I-5) in Colusa County.

The contractor will also obtain or update all necessary permits, licenses, and agreements including supporting environmental documents from appropriate regulatory and governmental agencies.

- All work will occur within the Caltrans Right-of-Way.
