The proposed, "Our Lady of Mt. Lebanon Project", located at 331-333 South San Vicente Boulevard and 8531-8555 West Burton Way, is located in Reporting District 0721. This "RD" falls within the geographical boundaries of the Los Angeles Police Department's Wilshire Division. A project of this size could have a minor impact on police services in the Wilshire Community area. The Department is available to advise you on crime prevention features appropriate for the design of the properties in this project. Upon completion of the project, you are encouraged to provide the Wilshire Community Police Station's Commanding Officer, Captain Timothy Nordquist, with a diagram of each portion of the property. The diagram should include access routes and any additional information that might facilitate police response.

The project site distances from the Wilshire Station are approximately 3.1 miles at 14 minutes for 331-333 South San Vicente Boulevard and 3.0 miles at 14 minutes for the 8531-8555 West Burton Way addresses. These distances and times are calculated from a departure point starting from the Wilshire Community Police Station. The Wilshire Station's Reporting District is RD 0765 and their Phone number is 213-473-0476. These arrival times are configured utilizing traffic delays.

Wilshire Station's Geographical Area is approximately 13.97 square miles and consists of 56 Reporting Districts. The service boundaries for Wilshire Area are as follows: To the west is La Cienega, Schumacher Drive, San Vicente, Clifton Way, North Robertson Boulevard, Burton Way, South Doheny Drive, Beverly Boulevard, North La Cienega, Rosewood Avenue, North Croft Avenue, Clinton Avenue, North Orlando Avenue, Rosewood Avenue, North Sweetzer Avenue, Melrose Avenue, La Cienega Boulevard.

To the North is Santa Monica Boulevard, North Kings Road, Waring Avenue, North Sweetzer Avenue, Willoughby Avenue, Crescent Heights Boulevard, Romaine Street, Hayworth Avenue, Willoughby Avenue, North Vista Street, Romaine Street, North La Brea Avenue, Willoughby Avenue, Seward Street, Melrose Avenue.

To the East is North Gower Street, Beverly Boulevard, North and South Plymouth Boulevard, Wilshire Boulevard, South Bronson Avenue, West 8th Street, Crenshaw Boulevard, Olympic Boulevard, South Bronson Avenue, Country Club Drive, Arlington Avenue.

To the South is The Santa Monica Freeway (10 Frwy), Washington Boulevard, South Fairfax Avenue, Washington Boulevard.

The proposed "Our Lady of Mount Lebanon Project" resides in RD 0721. The boundaries for RD 0721 are Beverly Boulevard to the north and North La Cienega Boulevard to the east. Clifton Way, North Robertson Boulevard and Burton Way are to the south. South Doheny Drive is to the west.

Wilshire Division has approximately 267 sworn personnel and 13 civilian support staff. Wilshire Division is a culturally diverse community with a residential population of 249,200 people. This amount does not reflect citizens visiting the local businesses and educational institutions. The officer to resident ratio is; 1 officer to every 933 residents (933:1). There are many specialized support teams and services available within the LAPD to supplement Wilshire Division's policing. With the available resources the Los Angeles Police Department has, the "Our Lady of Mount Lebanon" project's demand for police services can be met.

Wilshire Station's emergency response system is directly linked to the Los Angeles Police Departments' Communication Dispatch Center. Communication Division has the responsibility to staff and answer telephone calls for service on a 24- hour basis. This includes 9-1-1, emergency calls (police, fire and medical). Communication Division's main protocol is to handle and dispatch police calls for service in the City of Los Angeles.

According to the City's Computer Statistics (CompStats) report, the average police response time to emergency, high priority calls in the Wilshire area (Code 3 calls) was 4.2 minutes. The medium high priority response time (Code 2) was 11.9 minutes and the low priority, non-emergency response time is 30.0 minutes. These response times were taken from the statistics submitted by Wilshire Division for September 1, 2019 through September 28, 2019.

During this time period, Wilshire Division answered 307, emergency calls for service, 1,191 medium high priority calls and 1,731 low priority calls for service. The response times stated are adequate performance times for the police department.
