The South Central Coastal Information Center received your records search request for the project area referenced above, located on the La Habra and Yorba Linda, CA USGS 7.5' quadrangles. The following summary reflects the results of the records search for the project area and a 1-mile radius. The search includes a review of all recorded archaeological and built-environment resources as well as a review of cultural resource reports on file. In addition, the California Points of Historical Interest (SPHI), the California Historical Landmarks (SHL), the California Register of Historical Resources (CAL REG), the National Register of Historic Places (NRHP), and the California State Historic Properties Directory (HPD) listings were reviewed for the above referenced project site and a 1-mile radius. Due to the sensitive nature of cultural resources, archaeological site locations are not released.

**HISTORIC MAP REVIEW** – Anaheim (1896, 1942) 1:62,500 scale historic maps indicated that in 1896 there was one intermittent stream along Brea Canyon, which is northwest of the project area. There were also three improved roads. The place name of rancho San Juan Cajon de Santa Ana was visible on the map. In 1942 the town of Brea was already present. There were approximately 9 intermittent streams with three running through the project area. The area was quite developed with a grid-like system of improved roads, two of which ran through the project area. The Fullerton Reservoir was present as well as. There were many buildings in the area with four located within the project area. Two Churches and three schools were within the search radius and the Pacific Electric Railroad ran through the 1-mile radius to the north. Many oil wells were located to the south and were labeled Union Oil.

**RECOMMENDATIONS**

The archaeological sensitivity of the project location is unknown because there are no previous studies for the subject property. Additionally, the natural ground-surface appears to be obscured by urban development; consequently, surface artifacts would not be visible during a survey. While there are currently no recorded archaeological sites within the project area, buried resources could potentially be unearthed during project activities. Therefore, customary caution and a halt-work condition should be in place for all ground-disturbing activities. In the event that any evidence of cultural resources is discovered, all work within the vicinity of the find should stop until a qualified archaeological consultant can assess the find and make recommendations. Excavation of potential cultural resources should not be attempted by project personnel. It is also recommended that the Native American Heritage Commission be consulted to identify if any additional traditional cultural properties or other sacred sites are known to be in the area. The NAHC may also refer you to local tribes with particular knowledge of potential sensitivity. The NAHC and local tribes may offer additional recommendations to what is provided here and may request an archaeological monitor.
