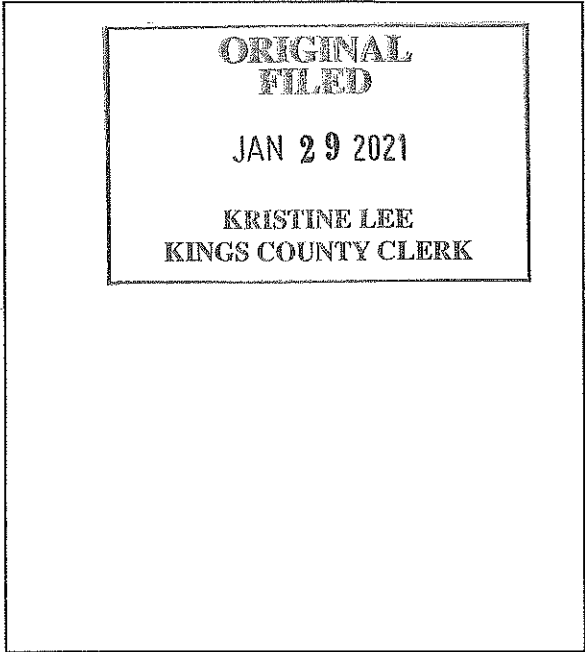

Project Location: Southwest corner of Utica Avenue and Interstate 5


Project Description: Consisting of approximately 415 acres along the west side of Interstate 5 at the Utica Avenue off-ramp, Jackson Ranch Specific Plan is envisioned as an innovative service and commercial center that will encourage economic growth while honoring the agricultural heritage of the region. A total of just under 2.4 million square feet of commercial and industrial space is planned for 141 acres of the 415-acre Plan Area. Approximately 268 acres is proposed to be designated for agriculture use.


